BATON ROUGE, La. – Members of the Postsecondary Education Review Commission will gather for their monthly meeting on Monday, January 11 and Tuesday January 12, 2010 in House Committee Room 1 of the Louisiana State Capitol beginning at 8:30 a.m. both days. The topic for the two-day meeting will be "Governance." Commissioners will discuss the current structure of governance for postsecondary education in Louisiana and whether it provides the most effective and cost efficient delivery of services. Mr. Aims McGuinness with the National Center for Higher Education Management Systems will present information concerning governance structures across the nation and be available to answer questions.

The Board of Regents will review the report and submit comments to the Legislature no later than February 26, 2010.
