## LOUISIANA STATE UNIVERSITY AT SHREVEPORT

#### Message from the Commissioner:

In compliance with the Higher Education Act of 1998, baseline data are being released on each university in Louisiana with a teacher preparation program as part of a nationwide public accountability effort that began this year. This evaluation of teacher preparation follows earlier and on-going efforts begun in 1999 by Louisiana's Blue Ribbon Commission on Teacher Quality, a systemic reform initiative coordinated by Governor Foster, Board of Regents, and the Board of Elementary and Secondary Education. The information in this report will be used by Regents and BESE as part of a statewide effort to recruit, prepare, and retain more effective teachers throughout the state. To that end, these institutional reports will help colleges and universities, PK-16+ Councils, and PK-16+ Redesign Teams to further improve their programs. Building on this year's data, report cards will be issued on each university annually, beginning next year, to disclose institutional efforts in preparing new teachers.

## Mission of University

Louisiana State University in Shreveport (LSUS) is a regional university primarily serving the educational and cultural needs of the Shreveport/Bossier metropolitan area and the Ark-La-Tex. The university provides a stimulating and supportive learning environment in which students, faculty, and staff participate freely in the creation, acquisition, and dissemination of knowledge. LSUS produces graduates who posses the intellectual resources and professional and personal skills that enable them to be effective and productive members of an ever-changing global community.

LSUS will meet the social, cultural, technological, and economic development needs of the region and expand its relationships with business, industry, and governmental, educational and community organizations. Continuing education and public service

activities will serve the region and raise the level of education as well as the quality of life for its citizens.

Located in Region VII, LSUS is categorized as a SREB Four-Year 5 institution and as a Carnegie Master's College and University I. The university will offer a wide range of baccalaureate programs and be committed to graduate education through the master's degree, offering graduate programs to meet regional/state needs. LSUS will enroll students in need of no more than one developmental education course, will limit associate degree offerings to 2+2 programs, will conduct research appropriate to academic programs offered and necessary for program accreditation, and will implement Selective III admissions criteria.

## **Student Characteristics of University**

During 1999-2000, Louisiana State University in Shreveport had a total enrollment of 3,557 undergraduate and 686 graduate students. A total of 1,613 students were males and 2,630 were females. The majority of the students were from Louisiana with a total of 4,114 in-state students, 122 out-of-state students, and 7 foreign students. Among students enrolled in the undergraduate program, 696 were black, 2,674 were white, and 187 were other races. Among students enrolled in the graduate program, 151 were black, 499 were white, and 36 were other races.

## Accreditation and Approval of Teacher Preparation Program

Louisiana State University at Shreveport is accredited by the Southern Association of Colleges and Schools (SACS) and by the National Council for the Accreditation of Teacher Education (NCATE). All of the university's teacher preparation programs are approved by the Board of Regents and the Louisiana Department of Education.

#### Notable Features and Accomplishments of Teacher Preparation Program

- One 1999-2000 program completer who did not pass all portions of the *Praxis* tests has since successfully completed all tests.
- Louisiana State University in Shreveport has, since July 1999, hosted cohorts of students seeking alternative certification in both Special Education and Elementary Education. A cohort of 25 students has been admitted in the two summers and each takes 40 hours of course work to attain the two certifications. They attend classes during the summer, one night per week during their teaching contract. They also take courses during the holidays and one Internet course. Upon successful completion of all course work, mentor evaluations, university evaluations, and portfolio presentations, each member of the cohort is recommended to the State Department of Education for certification.
- The College of Education at LSUS maintains a state-of-the-art educational technology laboratory. This Macintosh laboratory is equipped with hardware and software for every purpose appropriate for preparing students for teaching in the K-12 schools.
- The Curriculum Resources Center is a vital part of the College of Education. Among the holdings of the CRC are textbooks and teacher resources used by the school system, curriculum guides, a large variety of children's literature books, activity books, manipulatives, games, thematic units, and many other resources.

#### **Teacher Preparation Program Label**

The following labels will be assigned to all teacher preparation programs in Louisiana during April 2002 in conjunction with Louisiana's new Teacher Preparation Accountability System: Exemplary, Quality, Satisfactory, At-Risk, and Low-Performing. Labels have not been assigned to universities in this institutional report.
