Regents to Expedite Budget Reduction Plans

Commissioner of Higher Education Thibodaux, La. – The Board of Regents today urged the Commissioner of Higher Education to expedite the planning and implementation of budget cuts with the four system presidents in light of declining state revenue and future anticipated cuts to postsecondary education. The unanimous vote allows Regents staff to accelerate their work to identify budgetary savings totaling \$289 million which is the anticipated shortfall in 2012 due to the loss of federal stimulus money. Since 2008, higher education budgets have already been reduced by \$250 million dollars, a reduction of approximately 20%.

"The magnitude and impact of an additional \$300 million in cuts from our campus and system budgets will dramatically impact personnel, academic programs and the students we serve," said Commissioner of Higher Education Sally Clausen. "We have been directed to accelerate the budget reduction plans now, and that very serious work is underway."

Regents also discussed proposed legislation for the upcoming session during their two-day meeting at Nicholls State University and unanimously voted to support the Governor's signature piece of legislation, the LA GRAD Act. The GRAD Act, which stands for Granting Resources and Autonomy for Diplomas, gives colleges that sign 6-year contracts with the Board of Regents increased autonomy in exchange for increased performance.

The performance indicators to be measured include such things as raising graduation rates, increasing retention of students, increasing the number of students transferring between 2-year and 4-year institutions, and increasing the number of degrees awarded which meet identified workforce needs in the state. In return campuses will earn the ability to raise tuition as much as 10%, per year, increase the per unit tuition charges beyond the current 12-hour cap, and earn the ability to carry forward funds in exchange for performance.

"This is a significant piece of legislation for higher education," said Commissioner Clausen. "It demonstrates to the campuses that performance does indeed pay. This bill will provide a multi-faceted approach to ensure that our campuses improve their performance in key areas. The timing is right for this kind of policy and it is receiving great support from all of our system leaders."

The Regents also discussed increasing minimum statewide admissions requirements for college students entering a four-year university. The proposed changes to the standards would include the setting of a required Core GPA, decreasing developmental education at four year institutions, and decreasing admissions by exceptions. The Board of Regents sets the floor for admissions requirements statewide. The individual systems and campuses can have stricter rules for admissions if they choose.

The board could vote on the increased admissions standards at next month's meeting.
