

Regents Recap

Regents holds 5th Annual Trusteeship Conference

Baton Rouge, LA- Higher education system leaders gathered today for the 5th Annual Board of Regents' Trusteeship Conference held at Pennington. This one-day conference focused on *Emerging Trends in Higher Education*. The agenda consisted of presentations and panel discussions featuring the system presidents and staff, legislators, and national experts who conveyed the importance of Louisiana's role in keeping pace with the changing trends in higher education.

Opening remarks were made by Regents Chair, Roy O. Martin, who challenged higher education leaders to:

- (1) Continue seeking solutions for additional state support for higher education so that we can address the economic needs of our state;
- (2) Continue to focus on policies which institute efficiencies in delivering world class academic outcomes-with a goal of producing quality degrees- for THE BEST value in the US:
- (3) Continue aligning educational programs with the workforce demands of this state; and
- (4) Continue working TOGETHER and SPEAKING with one voice.

President of the Southern Association of Colleges and Schools Commission on Colleges, Dr. Belle Wheelan, set the tone of the Trusteeship Conference with a presentation which focused on principles of accreditation, roles of the board, and the top 10 issues in higher education. "Of everything you do at your institutions, your major focus should be students," said Wheelan.

Several legislators served as panelists for a discussion centered around the 2015 legislative priorities for higher education. "I look at this financial crisis as an opportunity," said Representative Steve Carter. "We need to take a long hard look, and think outside of the box to make sure that each younster has an opportunity for access to high quality education. Our higher education systems must survive."

Speaker of the House, Chuck Klecley stressed the importance of fixing the financial problem that higher education is facing, especially with the current economic growth in this state. "These companies have invested millions of dollars in our state and our area because of the confidence that they have in our state. They are depending on us to produce the skilled workforce they need. How can we do that by cutting higher ed 500M dollars? We have to find a way to fix this problem; higher ed needs predictability and stability," said Kleckley. He also added that closing universities is not the answer, but the answer is giving higher education a stable budget.

Senator Appel noted that for the first time there is an opportunity to address structural shortfalls in the total budget. "We need to find a way to fund higher education and increase its funding level. We should be talking about the future."

Regents Approves Uniform Policy on Sexual Misconduct

Today, the Louisiana Board of Regents approved a statewide uniform sexual misconduct policy. The Board of Regents in collaboration with the four management boards developed the policy which identifies best practices that serve to prevent and address incidents of sexual assault. Major components of the policy include:

- 1. All forms of sexual misconduct.
- 2. Flexibility for system implementation.
- 3. Concepts such as sexual harassment, retaliation, consent, etc. are included, expanded and clarified for institutions.
- 4. The incorporation of a uniform statewide campus climate survey that will be adopted and administered by all institutions.
- 5. General descriptions of education and prevention programs that must be annually offered to students.
- 6. A requirement for institutions to coordinate with local law enforcement and health organizations to address and resolve incidents of sexual misconduct as appropriate.
- 7. Resources that must be available to both the complainant and respondent following a report of sexual misconduct.
