The focus of the spring 2015 meeting will be educational leadership preparation. As noted on the agenda, the outcome of the September 23, 2014 meeting will be to have council members provide input pertaining to (1) improving redesigned teacher preparation programs, (2) communicating relevant information about redesigned teacher preparation programs to the public, and (3) identifying research questions to be answered about teacher preparation effectiveness. The meeting is being structured to provide advisory council members maximum time to have open discussions about each of these areas.

The attachment also provides an overview of Teacher Preparation Transformation 1.0 that occurred from 1999-2010 as major changes occurred in teacher certification and teacher preparation in Louisiana due to recommendations of the Blue Ribbon Commission for Educational Excellence. As you are aware from 2003 to 2010, all pre-redesign preparation programs in Louisiana were terminated and redesigned preparation programs were not approved until they were reviewed by national experts and met higher state expectations. Since 2010, the universities have continued to make changes to their programs as they embark upon Teacher Preparation Transformation 2.0 and integrate the State's new content standards and aligned assessments into their curriculum. If members do not have time to review the attached documents prior to the meeting, we will provide a brief overview of the changes at the beginning of the meeting.

Please fill out the attached document and return it to our office.

Again, we plan to use the input from this meeting and future council meetings to further improve the effectiveness of new teachers and leaders who complete our programs.
